A Deposit of 50% is required for all session bookings. The deposit will be applied towards the total session fees. In making payment of your deposit you acknowledge that in the case of cancellation: If cancelled with a 60+ days notice, we will refund your deposit, less a \$50 service and handling fee. If cancelled 15 - 60 days prior you will be charged a cancellation fee of 50% of the deposit. If cancelled within 15 days of your booking date, the deposit is not refundable. If cancelled within 48 hours of your booking date, the deposit is not refundable and a cancellation fee equal to the unpaid balance of the full quoted rate will be due.

POSTPONEMENTS: Postponements may result in re-booking fees dependent on the date of request.

AVAILABILITY AND BOOKINGS: Availability is not guaranteed without an acceptance of the terms and conditions of this agreement and our receipt of your deposit. We have a first come, first served booking policy. Bookings go to the first party to put a deposit on the time and date.
